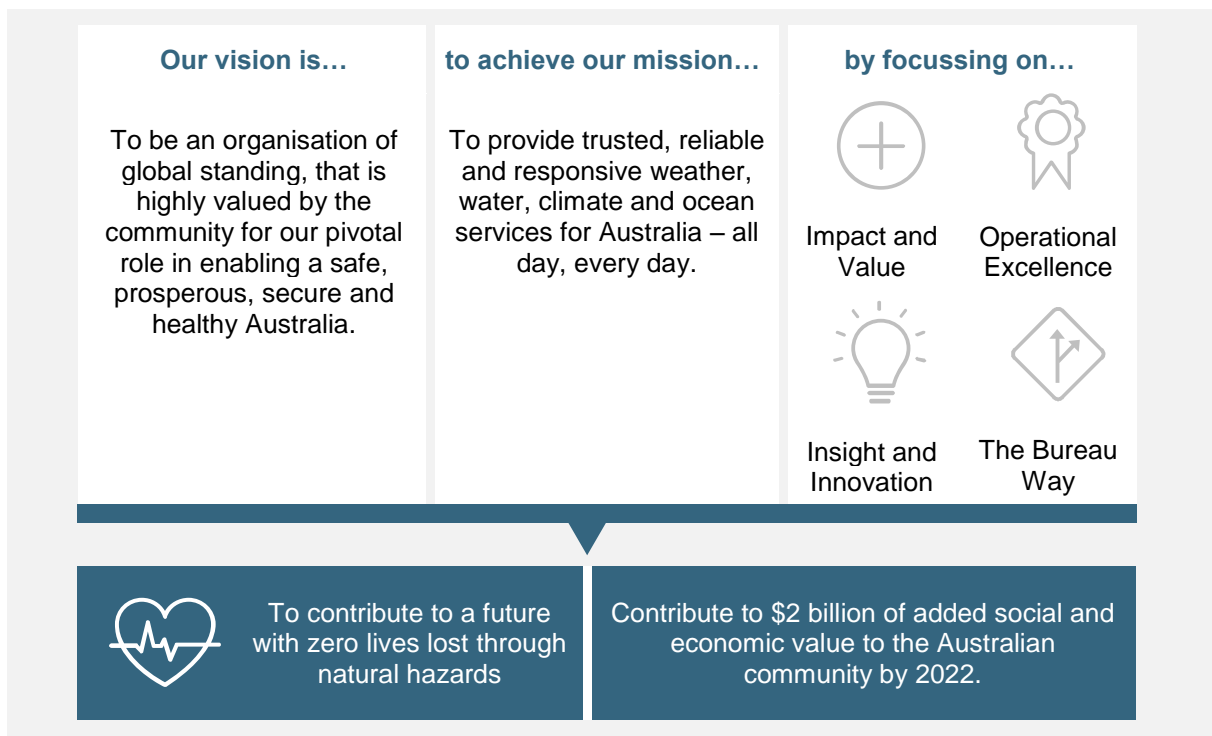
## ABOUT US

## POSITION OVERVIEW

The Security Vulnerability Management Tester is an information security specialist who contributes to the implementation and administration of information security policies and procedures and ensures that information systems are maintained in accordance with security policies.

The role performs various investigations into potential and existing security threats; evaluates security policies to ensure compliance; trouble shoots security issues; assesses and reports on security risks; and presents security risk, policy and compliance issues to technical and non-technical stakeholders to ensure compliance.

Reporting to the Cyber Security Defence Centre Manager, the role works closely across all functions within the Cyber Security Centre, and in particular with members of the CSDC team.

## ROLE RESPONSIBILITIES

The responsibilities of the role include but are not limited to:

1. Perform configuration and deployment vulnerability scanning and network assessments.
2. Provide customised results and risk assessments of vulnerabilities identified.
3. Perform asset discovery scans and categorise and tag assets.
4. Document remediation tasks to application and system owners.
5. Track vulnerabilities from identification through to remediation using the available service management ticketing system.
6. Manage asset, configuration and vulnerability data bases.
7. Perform deep-dive analysis of vulnerabilities by correlating data from various sources, determine impacts and advise on remediation.
8. Troubleshoot performance and connectivity issues with network scanning and security assessment tools.



9. Support cyber defence operational monitoring, issue and incident response as part of day-to day operations.
10. Provide timely, comprehensive and accurate information to the cyber Security Defence Centre Manager and team in both written and verbal communications.
11. Proactively research and monitor security-related information sources to aid vulnerability discovery.
12. Undertake other tasks as directed.
13. Complying with all Bureau work, health and safety policies and procedures, and taking reasonable care for your own health and safety and that of employees, contractors and visitors who may be affected by your conduct.

## SELECTION CRITERIA

The Bureau encourages applications from all suitably qualified candidates. Applications will be considered based on alignment with selection criteria, which have been matched to the APSC Work Level Standard and Integrated Leadership Systems for EL1 positions.

1. Considerable knowledge and experience working with information security policy and controls frameworks as these apply to vulnerability management work.
2. Strong experience in developing assessment methodologies and performing and supporting vulnerability scanning using a range of tools in relevant environments.
3. Strong experience in information security risk management, including risk assessments, maturity assessments and selection and implementation of counter measures and compensating controls.
4. Strong experience in reporting and dissemination of vulnerability assessment findings, issues and incident investigation analysis and recommended actions.
5. Solid understanding of one or more of the following platforms: Linux, Infrastructure, Networking and Cloud/Virtualisation.
6. Strong experience in undertaking and supporting cyber security work experience including working knowledge of controls and maturity frameworks for information security (such as, OWASP, OSSTMM, NIST CSF, ISM, ASD Essential 8) including information security best practice standards and guidelines (e.g. ISO 27001).
7. Proven ability to work with a diverse range of technical and non-technical stakeholders.
8. Demonstrated ability to effectively and efficiently prioritise workload, stay on track and consistently meet deadlines.
9. Understanding of the Bureau's diversity and inclusion statement of commitment and APS Values and Code of Conduct
